TAKE HOME EXAMS:

Administrative Law – Flournoy – This course will have a take home exam on TWEN.

Advanced Legal Research—Professors Morgan and Outler—This course will have a 24-hour take home that the student will download on TWEN any time during the two week final examination period.

Affordable Housing – Jourdan - This course will have a take home exam.

Civil Procedure II – Professor Lear – This course will have an 8 hour take home exam. Students will be allowed to pick up the exam in the Dean's Office at 8:30 a.m. any day during the exam period and return it by 4:30 p.m.

Comparative Law – Malavet – This course will have a take home exam.

Conflict of Laws – Professor Lear - This course will have an 8 hour take home exam. Students will be allowed to pick up the exam in the Dean's Office at 8:30 a.m. any day during the exam period and return it by 4:30 p.m.
