**TAKE HOME EXAMS (Set Day and Time):**

**Natural Resources (Klein):**

The exam will be available on TWEN beginning at 6:00 a.m. on December 5 and ending at midnight on December 7. It must be taken and completed within any 4-hour window during that period. Exceptions for exam conflicts will be considered on an individual basis.

**International Law (Nagan)**

Students will have access to the exam on December 10 and will be given 24 hours to complete the exam. Please see the instructor for further details.

**Administrative Law (Flournoy):**

This exam is scheduled for December 11. Students will have 7 hours to complete the exam. Room 270 has been assigned for students who may wish to take the exam on campus.

**Florida Constitutional Law (Mills):**

This exam is scheduled for December 15. Students will have 4 hours to complete the exam. They will download it from TWEN at 8:30 a.m. and must upload to TWEN by 12:30 p.m.
