TAKE HOME EXAMS (SET DAY AND TIME):

Constitutional Law (Rush: Section 2): Take home exam scheduled on December 4th. The exam will be available to download on TWEN at 8:30 a.m. and must be submitted by 4:00 p.m.

Corporate Finance (Rhee): 24 hour take home exam scheduled on Tuesday, December 8th.
